## ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS – SOUTH LANARKSHIRE COUNCIL RESIDENTS RESTRICTED PARKING ZONES, EAST KILBRIDE

The Scottish Ministers' in exercise of the powers conferred upon them by sections 64 and 65 of the Road traffic Regulation Act 1984 and of all other powers enabling them in that behalf, hereby:-

- 1. authorise the erection and use at or within 5 metres of the sites indicated on the attached drawing number NPS/1/SL/2013/1 of traffic signs conforming in size, colour and character with those shown on the attached drawing number NPS/1/SL/2013/1/1 (without the use of diagram 1017), for the purpose of indicating the restriction in force within the Restricted parking zone.
- 2. direct that the zone legend "The Murray" as shown on the attached drawing numbered NPS/SL/2013/1/2 may be varied to accommodate the other zone legends as indicated on drawing numbered NPS/1/SL/2013/1.
- 3. direct that direction 24(1) of the Traffic Signs regulations and General Directions 2002 (S.I. 2002 No 3113) shall be disapplied from the authorised signs shown on Plan NPS/1/SL/2013/1.
- 4. direct that the provisions of Tables 1 and 4 of regulation 12 and direction 7 of the aforementioned Regulations shall apply where appropriate to the aforementioned signs as if were a diagram in Schedule 2 to those Regulations: and;
- 5. direct that illumination of the authorised signs shall be as shown in Schedule 17, item 9 to the aforementioned Regulations; and
- 6. direct that it is a condition of this authorisation that the erection and use of the authorised signs shall continue to effect only until such day as may be appointed by the Scottish Ministers' in writing to the relevant authority for the removal or alteration of the authorised signs and on that day the said authorisation shall without prejudice to the giving of any further authorisation or direction cease to have effect.

This authorisation supersedes that authorisation for East Kilbride dated 17 May 2007.






