

**ARGYLL AND BUTE COUNCIL
(A814 MAIN ROAD, CARDROSS)
(WAITING RESTRICTION)
(AMENDMENT) ORDER 2018**

Argyll and Bute Council in exercise of the powers conferred on them by section 1(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other powers enabling them to do so, and after consultation with a Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act, and having complied with Part II of the Local Authorities' Traffic Orders (Procedure) (Scotland) Regulations 1999, hereby make the following Order:

- 1 This Order may be cited as "Argyll and Bute Council (A814 Main Road, Cardross) (Waiting Restriction) (Amendment) Order 2018" and shall come into operation on Monday the twenty sixth day of March Two Thousand and Eighteen.
- 2 The Interpretation Act 1978 shall apply for the interpretation of this Order and of all Orders revoked by this Order as it applies for the interpretation of an Act of Parliament.
- 3 Upon the coming into operation of this Order the Order specified in the Schedule to this Order under 'Name of Order' shall have effect subject to the amendments specified in the Schedule to this Order under 'Extent of Amendment'.


