**(TRAFFIC MANAGEMENT SCHEME)
ORDER 2017**

The East Dunbartonshire Council in exercise of the powers conferred on them by sections 1(1), 2(1) to (3), 4(2), 32(1), 35(1), 81 to 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of the Police Service of Scotland in accordance with Part III of Schedule 9 to the Act hereby make the following Order.

1. This Order may be cited as "The East Dunbartonshire Council (Kirkintilloch) (Traffic Management Scheme) Order 2017 and shall come into operation on 8 January 2018

2. In this Order the following expressions have the meanings hereby assigned to them:-

"buses" mean (i) motor vehicles constructed or adapted to carry more than 8 passengers (exclusive of the driver), and (ii) local buses not so constructed or adapted;

"Council" means the East Dunbartonshire Council incorporated under the Local Government etc (Scotland) Act 1994;

"disabled person's badge" has the same meaning as in the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (Scotland) Regulations 2002;

"Doctor" means a fully registered person within the meaning of the Medical Act 1983;

"emergency services vehicle" means a vehicle being used by the Police, Fire Brigade or Ambulance Services;

"local authority" means a Council constituted by Section 2 of the Local Government etc (Scotland) Act 1994;

"local service" has the same meaning as in the Transport Act 1985;

"taxi" has the same meaning as in Section 23(1) of the Civic Government (Scotland) Act 1982;

"vehicle" unless the context otherwise requires, means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along roads whether or not by mechanical power.

3. Save as provided in Article 7 of this Order no person shall, except upon the direction or with permission of a police constable in uniform or a parking attendant in uniform, cause or permit any vehicle to stop in the lengths of roads specified in Schedule 1 to this Order.
4. Save as provided in Article 7 of this Order no person shall, except upon the direction or with permission of a police constable in uniform or a parking attendant in uniform, cause or permit any vehicle to stop in the lengths of roads specified in Schedule 2 to this Order.
5. Save as provided in Article 7 of this Order no person shall, except upon the direction or with permission of a police constable in uniform or a parking attendant in uniform, cause or permit any vehicle, other than buses providing a local service, to stop at any time in the lengths of roads specified in Schedule 3 to this Order.
6. Save as provided in Article 7 of this Order no person shall, except upon the direction or with permission of a police constable in uniform or a parking attendant in uniform, cause or permit any vehicle, other than buses providing a local service, to stop between the hours of 8:30 am to 9:30 am and between 2:30 pm to 3:30 pm, Monday to Friday inclusive, in the lengths of roads specified in Schedule 4 to this Order.
7. Nothing in Articles 3, 4, 5, 6 and 26 shall apply:-
 - (a) so as to prevent any vehicle waiting in the said lengths of roads for so long as may be necessary to enable the vehicle, if it cannot be used for such purpose without so waiting, to be used in connection with any building operation or demolition being carried on adjacent thereto, the removal of any obstruction or potential obstruction to traffic, the maintenance, testing, alteration, repair or removal of any structure, works, or apparatus in, on, under or over the road;
 - (b) to an emergency services vehicle;
 - (c) to a vehicle being used in the service of the local authority or with the permission of the local authority in exercise of statutory powers and duties if it is necessary for the vehicle while being so used to wait in the said lengths of road;
 - (d) to a vehicle waiting in any case where the person in control of the vehicle:-
 - (i) is required by law to stop;
 - (ii) is obliged to do so in order to avoid an accident;
 - (iii) is prevented from proceeding by circumstances outwith his control and it is not reasonably practicable for him to drive or move the vehicle to a place not within the said lengths of road.
8. Save as provided in Article 17 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a parking

attendant in uniform, cause or permit any vehicle to wait at any time in the lengths of roads specified in Schedule 5 to this Order.

9. Save as provided in Article 17,18 and 19 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a parking attendant in uniform, cause or permit any vehicle to wait at any time, in any of the lengths of roads specified in Schedule 6 to this Order.
10. Save as provided in Article 17 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a parking attendant in uniform, cause or permit any vehicle to wait at any time between the hours of 8:00 am and 6:00 pm, Monday to Saturday inclusive, in any of the lengths of roads specified in Schedule 7 to this Order.
11. Save as provided in Article 17, 20 and 24 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a parking attendant in uniform, cause or permit any vehicle to wait between the hours of 8:00 am and 6:00 pm, Monday to Saturday inclusive, in any of the lengths of roads specified in Schedule 8 to this Order
12. Save as provided in Article 17 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a parking attendant in uniform, cause or permit any vehicle to wait at any time between the hours of 8:30 am to 9:30 am and between the hours of 2:30 pm to 4:30 pm, Monday to Friday inclusive, in any of the lengths of roads specified in Schedule 9 to this Order.
13. Save as provided in Article 17, 21 and 25 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a parking attendant in uniform, cause or permit any vehicle to wait at any time in any of the lengths of roads specified in Schedule 10 to this Order.
14. Save as provided in Article 17, 21 and 25 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a parking attendant in uniform, cause or permit any vehicle to wait at any time between the hours of 8:00 am to 6:00 pm, Monday to Saturday inclusive, in any of the lengths of roads specified in Schedule 11 to this Order.
15. Save as provided in Articles 17, 22 25 and 43 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a parking attendant in uniform, cause or permit any vehicle to wait between the hours of 8:00 am and 6:00 pm, Monday to Saturday inclusive in the length of road specified in Schedule 12 to this Order:-

(a) for a longer period than 2 hours; or

- (b) if a period of less than 1 hour has elapsed since the last period of waiting of the vehicle in the said length of road.
16. Save as provided in Articles 17, 23 and 25 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a parking attendant in uniform, cause or permit any vehicle to wait between the hours of 8:30 am and 9:30 am and between the hours of 2:30 pm and 4:30 pm, Monday to Friday inclusive in the length of road specified in Schedule 13 to this Order:-
- (a) for a longer period than 20 minutes; or
- (b) if a period of less than 40 minutes has elapsed since the last period of waiting of the vehicle in the said length of road.
17. Nothing in Article 8, 9, 10, 11, 12, 13, 14, 15 and 16 of this Order shall :-
- (a) prevent any person from causing or permitting a vehicle to wait in any of the lengths of road referred to in that Article:-
- (i) for so long as may be necessary to enable a person to board or alight from the vehicle or to load thereon or unload therefrom their personal luggage;
- (ii) for so long as may be necessary to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of roads so referred to, or the laying, erection, alteration or repair in or near to any of the said lengths of roads, of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus as defined in the Telecommunications Act 1984, as amended;
- (iii) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of statutory powers and duties and in particular, but without prejudice to the generality of the foregoing, to enable the vehicle to be used in connection with police, fire brigade and ambulance purposes;
- (iv) if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond their control or to such waiting being necessary in order to avoid an accident;
- (v) if the vehicle is waiting in any of the lengths of roads while postal packets addressed to premises adjacent thereto are being unloaded from the vehicle or having been unloaded therefrom are being delivered or while postal packets are being collected from premises or posting boxes adjacent thereto;

- (vi) for the purpose of loading or unloading the vehicle while the vehicle is standing at the kerb and is in actual use in connection with the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository;
 - (vii) to enable the vehicle to be used in connection with wedding and funeral operations.
 - (b) apply to a licenced taxi waiting in a taxi stance during any period for which that stance has been designated by the Council under the Civic Government (Scotland) Act 1982.
18. Nothing in Article 9 of this Order shall prevent any person from causing or permitting a vehicle to wait in the lengths of road referred to in that Article between the hours of 9:30 am to 4:30 pm and between 6:00 pm to 8:00 am, Monday to Saturday inclusive and between 6:00 pm Saturday to 8:00 am Monday:-
- (a) for so long as may be necessary for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle at premises adjoining that road provided that no vehicle engaged in delivering or collecting goods or merchandise or being loaded or unloaded shall wait for a longer period than 30 minutes in the same place and no such vehicle shall wait for a longer period than 10 minutes in the same place without goods being loaded onto or unloaded from the vehicle;
 - (b) notwithstanding anything in paragraph (a) of this Article the driver waiting for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle shall move the same on the instruction of a police constable in uniform or a parking attendant in uniform, whenever such moving may be reasonably necessary for the purpose of preventing an obstruction.
19. Nothing in Article 9 of this Order shall apply to any vehicle between the hours of 9:30 am to 4:30 pm and between 6:00 pm to 8:00 am, Monday to Saturday inclusive, and between 6:00 pm Saturday to 8:00 am Monday, which is not causing an obstruction and which displays a disabled person's badge.
20. Nothing in Article 11 of this Order shall prevent any person from causing or permitting a vehicle to wait in the lengths of roads referred to in that Article between the hours of 9:30 am to 4:30 pm, Monday to Saturday inclusive
- (a) for so long as may be necessary for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle at premises adjoining that road provided that no vehicle engaged in delivering or collecting goods or merchandise or being loaded or unloaded shall wait for a longer period than 30 minutes in the same place and no such vehicle shall wait for a longer period than 10

minutes in the same place without goods being loaded onto or unloaded from the vehicle;

- (b) not withstanding anything in paragraph (a) of this Article the driver waiting for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle shall move the same on the instruction of a police constable in uniform or a parking attendant in uniform, whenever such moving may be reasonably necessary for the purpose of preventing an obstruction.

21. Nothing in Article 13 and 14 of this Order shall prevent any person from causing or permitting a vehicle to wait in the lengths of roads referred to in that Article

- (a) for so long as may be necessary for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle at premises adjoining that road provided that no vehicle engaged in delivering or collecting goods or merchandise or being loaded or unloaded shall wait for a longer period than 30 minutes in the same place and no such vehicle shall wait for a longer period than 10 minutes in the same place without goods being loaded onto or unloaded from the vehicle;

- (b) not withstanding anything in paragraph (a) of this Article the driver waiting for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle shall move the same on the instruction of a police constable in uniform or a parking attendant in uniform, whenever such moving may be reasonably necessary for the purpose of preventing an obstruction.

22. Nothing in Article 15 of this Order shall prevent any person from causing or permitting a vehicle to wait in the lengths of roads referred to in that Article

- (a) for so long as may be necessary for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle at premises adjoining that road provided that no vehicle engaged in delivering or collecting goods or merchandise or being loaded or unloaded shall wait for a longer period than 2 hours in the same place and no such vehicle shall wait for a longer period than 10 minutes in the same place without goods being loaded onto or unloaded from the vehicle;

- (b) not withstanding anything in paragraph (a) of this Article the driver waiting for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle shall move the same on the instruction of a police constable in uniform or a parking attendant in uniform, whenever such moving may be reasonably necessary for the purpose of preventing an obstruction.

23. Nothing in Article 16 of this Order shall prevent any person from causing or permitting a vehicle to wait in the lengths of roads referred to in that Article

- (a) for so long as may be necessary for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle at premises adjoining that road provided that no vehicle engaged in delivering or collecting goods or merchandise or being loaded or unloaded shall wait for a longer period than 20 minutes in the same place and no such vehicle shall wait for a longer period than 10 minutes in the same place without goods being loaded onto or unloaded from the vehicle;
 - (b) notwithstanding anything in paragraph (a) of this Article the driver waiting for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle shall move the same on the instruction of a police constable in uniform or a parking attendant in uniform, whenever such moving may be reasonably necessary for the purpose of preventing an obstruction.
- 24. Nothing in Article 11 of this Order shall apply to any vehicle between the hours of 9:30 am to 4:30 pm, Monday to Saturday inclusive, which is not causing an obstruction and which displays a disabled person's badge.
- 25. Nothing in Article 13, 14, 15 and 16 of this Order shall apply to any vehicle which is not causing an obstruction and which displays a disabled person's badge.
- 26. Save as provided in Article 7 to this Order no person shall except upon the direction or with the permission of a police constable in uniform or a parking attendant in uniform, cause or permit any vehicle to stop or wait at any time except for the purpose of dropping off or picking up, for no longer than a maximum period of 10 minutes, in the length of road specified in Schedule 14 to this Order.
- 27. Each area of a road which is described in Column 2 of Schedule 15 to this Order is hereby designated as a parking place.
- 28. The parking places designated in Article 27 of this Order shall only be used subject to the provision of this Order for the leaving, at all times, of a vehicle displaying a disabled person's badge, provided that no such vehicle shall wait for a period exceeding two hours.
- 29. The number of parking bays in each parking place shall be as specified in Column 3 of Schedule 15 to this Order in relation to that parking place.
- 30. The limits of each parking place designated in Article 27 of this Order and the limits of each parking bay in a parking place shall be indicated on the carriageway in such a manner as provided in the Traffic Sign Regulations and General Directions 2016.
- 31. Every vehicle displaying a disabled person's badge left in a parking place designated in Article 27 of this Order shall so stand such that no bay is occupied by more than one such vehicle and that every part of the vehicle is within the limits of a parking bay provided that, where the length of a vehicle

precludes compliance with this paragraph, such vehicle shall be deemed to be within the limits of a parking bay if:-

- (i) the extreme front portion, or, as the case may be, the extreme rear portion of the vehicle is within 300mm of an indication on the carriageway provided under Article 30 of this Order in relation to the parking bay; and
 - (ii) the vehicle, or any part thereof, is not within the limits of any adjoining parking bay.
32. Any person duly authorised by the Council or a police constable in uniform or a parking attendant in uniform may move or cause to be moved in case of an emergency, to any place they think fit, a vehicle displaying a disabled person's badge left in a parking place designated in Article 27.
33. (i) Any person duly authorised by the Council may suspend the use of a parking place designated in Article 27 or any part thereof whenever such suspension is considered reasonably necessary:-
- (a) for the purpose of facilitating the movement of traffic or promoting its safety; or
 - (b) for the purpose of any building operation, demolition or excavation in or adjacent to the parking place or the maintenance, improvement or reconstruction of the parking place or the laying, erection, alteration, removal or repair in or adjacent to the parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus, traffic sign or parking meter; or
 - (c) for the convenience of occupiers of premises adjacent to the parking places on any occasion of the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository; or
 - (d) on any occasion on which it is likely by reason of some special attraction that any street will be thronged or obstructed; or
 - (e) for the convenience of occupiers of premises adjacent to the parking place at times of weddings or funerals, or on other special occasions;
- (ii) A police constable in uniform or a parking attendant in uniform may suspend the use of a parking place designated in Article 27 or any part thereof whenever such suspensions is considered reasonably necessary

for the purpose of facilitating the movement of traffic or promoting its safety.

34. Each area of a road which is described in Column 2 of Schedule 16 to this Order is hereby designated as a Doctor's parking place.
35. The parking places designated in Article 34 of this Order shall only be used subject to the provision of this Order for the leaving, of a vehicle displaying a Doctor's Parking Permit issued by the Council, between the hours of 8:00 am and 6:00 pm, Monday to Friday inclusive
36. The number of parking bays in each parking place shall be as specified in Column 3 of Schedule 16 to this Order in relation to that parking place.
37. The limits of each parking place designated in Article 34 of this Order and the limits of each parking bay in a parking place shall be indicated on the carriageway in such a manner as provided in the Traffic Sign Regulations and General Directions 2016.
38. Every vehicle displaying a Doctor's Parking Permit left in a parking place designated in Article 34 of this Order shall so stand such that no bay is occupied by more than one such vehicle and that every part of the vehicle is within the limits of a parking bay provided that, where the length of a vehicle precludes compliance with this paragraph, such vehicle shall be deemed to be within the limits of a parking bay if:-
 - (iii) the extreme front portion, or, as the case may be, the extreme rear portion of the vehicle is within 300mm of an indication on the carriageway provided under Article 37 of this Order in relation to the parking bay; and
 - (iv) the vehicle, or any part thereof, is not within the limits of any adjoining parking bay.
39. Any person duly authorised by the Council or a police constable in uniform or a parking attendant in uniform may move or cause to be moved in case of an emergency, to any place they think fit, a vehicle displaying a Doctor's Parking Permit left in a parking place designated in Article 34.
40. (i) Any person duly authorised by the Council may suspend the use of a parking place designated in Article 34 or any part thereof whenever such suspension is considered reasonably necessary:-
 - (b) for the purpose of facilitating the movement of traffic or promoting its safety; or
 - (b) for the purpose of any building operation, demolition or excavation in or adjacent to the parking place or the maintenance,

improvement or reconstruction of the parking place or the laying, erection, alteration, removal or repair in or adjacent to the parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus, traffic sign or parking meter; or

(c) for the convenience of occupiers of premises adjacent to the parking places on any occasion of the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository; or

(di) on any occasion on which it is likely by reason of some special attraction that any street will be thronged or obstructed; or

(e) for the convenience of occupiers of premises adjacent to the parking place at times of weddings or funerals, or on other special occasions;

(iii) A police constable in uniform or a parking attendant in uniform may suspend the use of a parking place designated in Article 34 or any part thereof whenever such suspension is considered reasonably necessary for the purpose of facilitating the movement of traffic or promoting its safety.

41. No person shall drive or cause or permit to be driven any vehicle on the lengths of roads specified in Column 1 of the Schedule 17 to this Order otherwise than in the direction specified in Column 2 of the said Schedule.

42. Residential Exemption Permits shall :-

(i) be made available only in respect of residential properties.

(ii) Only one residential exemption permit per property will be issued, irrespective of the number of people resident in the property at any time.

(iii) Can only be used in the lengths of road detailed on the permit.

(iv) Residents of properties where there is a private parking facility or where there is parking provision will not be eligible for a permit

(v) There shall be endorsed on any residential parking permit the vehicle registration number relating to the vehicle for which the permit was granted, and any residential exemption permit shall be valid only in respect of that vehicle.

- (vi) There shall be a cost payable on application for a residential exemption permit and once granted, shall be renewed, on application, one year after the date of issue at a cost.
 - (vii) The appropriate office of the Council shall require sight of any suitable documentation in connection with the need to determine whether or not an applicant to hold a residential exemption permit is eligible to do so.
 - (viii) In the event of failure to produce the necessary relevant documentation then the Council shall be entitled to refuse to issue a residential permit for that person.
 - (ix) The Council shall maintain a database of all residential exemption permit holders pertaining to off-street car parks.
 - (x) Residential exemption permits require to be exhibited on the vehicle in a prominent and conspicuous position.
43. A vehicle displaying a valid residential exemption permit (as provided in Article 42 of this order), shall be exempt from compliance with any limitations of time during which a vehicle may be left on the length of road specified in this order.
44. The Order specified in Schedule 18 to this Order shall have effect subject to the amendments specified in the said Schedule.
45. The Orders specified in Schedule 19 to this Order are hereby revoked.

1. From a point 11 metres north of the extended north kerbline of Saramago Street Northwards then eastwards then south-eastwards to a point 50 metres west of the extended southwest kerbline of Loch Road.

Northwest / North

2. From the extended north kerbline of Saramago Street northwards then eastwards then south-eastwards to a point 50 metres northwest of the extended southwest kerbline of Loch Road.

Southeast / South

New Lairdsland Road

1. From the extended southeast kerbline of the A803 Glasgow Road south-eastwards to the extended north kerbline of Parliament Road.

1. From a point 29 metres southeast of the extended southeast kerbline of Broadcroft south-eastwards for a distance of 15 metres. Northeast

2. From a point 67 metres southeast of the extended southeast kerbline of West High Street south-eastwards for a distance of 24 metres. Southwest

New Lairdsland Road

1. From a point 27 metres northwest of the extended north kerbline of High Street north-westwards for a distance of 34 metres. Northwest

2. From a point 34 metres southeast of the extended southeast kerbline of High Street south-eastwards for a distance of 34 metres. Northwest

3. From a point 140 metres southeast of the extended southeast kerbline of the A803 Glasgow Road south-eastwards for a distance of 34 metres. Southeast

4. From a point 307 metres southeast of the extended southeast kerbline of the A803 Glasgow Road south-eastwards for a distance of 24 metres. Southeast

Parliament Road

1. From a point 80 metres southeast of the extended east kerbline of New Lairdsland Road south-eastwards for a distance of 20 metres. Northeast

Townhead

1. From a point 37 metres northeast of the extended northeast kerbline of Donaldson Street north-eastwards for a distance of 17 metres. Northwest
