East Lothian Council (Roads Adjacent to Schools) (Prohibition of Waiting and Loading and Unloading) (Variation No. 2) Order 2013

East Lothian Council in exercise of the powers conferred on them by Sections 1(1), 2 (1) and (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Traffic Commissioner and the Chief Constable of Police Scotland in accordance with Part III and V of Schedule 9 to the Act hereby make the following Order.

Citation

- This Order may be cited as the "East Lothian Council (Roads Adjacent to Schools) (Prohibition of Waiting, Loading and Unloading) (Variation No. 2) Order 2013" and shall come into effect on the Fourth day of May Two Thousand and Fifteen.
- 2. The restriction imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made under the 1984 Act or by or under any other enactment.
- 3. This Order amends "East Lothian Council (Roads Adjacent to Schools) (Prohibition of Waiting, Loading and Unloading) Order 2007", which shall hereinafter be referred to as the Principal Order.
- 4. The provisions of the Principal Order, in so far as they are inconsistent with this Order, are hereby revoked.

Interpretation

- 5. In this Order, all terms will continue to have the meanings assigned to them in the Principal Order.
- 6. In this Order:
 - a. "Chief Constable" means the Chief Constable of Police Scotland.
 - b. "designated parking bay" means a space in a designated parking place which is provided for the leaving of a vehicle;
 - c. "designated parking place" means areas on roads designated as parking places;
 - d. "disabled person's badge" has the same meaning as regulation 3(1) of the Disabled Persons (Badges for Motor Vehicles) Regulations 1982;
 - e. "disabled person's vehicle" has the same meaning as in The Local Authorities Traffic Orders (Exemptions for Disabled Persons) (Scotland) Regulations 1991;
 - f. "relevant position" has the same meaning as in regulation 4 of the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (Scotland) Regulations 1991.

Disabled Person's Vehicle Parking Places

- 13. The area of road specified in Column 1 of Schedule 1 to this Order is authorised for use as a parking place containing a number of parking bays not exceeding the number specified in Column 2 of Schedule 1 to this Order, such parking place only to be used by disabled person's vehicles displaying in the relevant position a disabled person's badge and that in accordance with the following provisions:
 - a. The limits of the parking place specified in Column 1 of Schedule 1 to this Order and the limits of each parking bay in the parking place shall be indicated on the carriageway in such a manner as the Council may determine by signs, carriageway markings, lines or other indications.
 - b. Every vehicle left in a parking place in Column 1 of Schedule 1 to this Order shall so stand such that no parking bay is occupied by more than one vehicle and that every part of that vehicle is within the limits of a parking bay provided where the length of a vehicle precludes compliance with this paragraph, such vehicle shall be deemed to be within the limits of a parking bay if:
 - The extreme front portion of the vehicle is within 300 millimetres of an indication on the carriageway provided under this article in relation to the parking bay; and
 - ii. The vehicle or any part thereof, is not within the limits of any adjoining parking bay;
 - c. Any person duly authorised by the Council or a Police Constable in uniform or a traffic warden may move or cause to be moved in case of an emergency, to any place he or she thinks fit, any vehicles left in the parking places specified in Column 1 of Schedule 1 of this Order.
 - d. Any person duly authorised by the Council may suspend the use of parking place specified in Column 1 of Schedule 1 to this Order or any part thereof whenever such suspension is considered reasonably necessary:
 - i. for the purpose of facilitating the movement of traffic or promoting its safety.
 - ii. for the purpose of any building operation, demolition or excavation in or adjacent to the parking place or the maintenance, improvement or reconstruction of the parking place or the laying, erection, alteration, removal or repair in or adjacent to the parking place of any sewer or of any main, pipe, apparatus for the supply of gas, water, electricity or of any telecommunication apparatus, traffic sign or parking ticket machine.

No Waiting Except Buses

14. Save as provided in Article 15 of this Order, no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle other than a public service vehicle to wait at any time at a bus stop on the roads specified in Schedule 2 to this Order

- 15. Nothing in Article 14 of this Order shall:
 - a. Prevent any person from causing or permitting a vehicle to wait in any of the lengths of road referred to in Schedule 2:
 - i. For so long as may be necessary to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of road so referred to, or the laying, erection, alteration or repair in or near to any of the said lengths of the roads, of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or any telecommunications apparatus.
 - ii. For so long as it may be necessary to enable the vehicle, if it cannot be used for such purpose in any other road, to be used in pursuance of statutory powers and duties and in particular, but without prejudice to the generality of the foregoing to be used as an emergency service vehicle.
 - iii. If the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or if such waiting is necessary to avoid an accident.
 - iv. If the vehicle is in the service of or employed by the Post Office and is waiting in any of the lengths of the roads while postal packets addressed to premises adjacent thereto are being unloaded from the vehicle or having been unloaded therefrom are being delivered or while postal packets are being collected from premises or pillar boxes adjacent thereto.
 - v. For the purpose of loading or unloading the vehicle while the vehicle is standing at the kerb and is in actual use in connection with the removal of furniture from one office or dwelling house to another office or dwelling house or the removal of furniture from such premises to a depository or to such premises from a depository.
 - vi. To enable the vehicle to be used by a qualified medical practitioner engaged on a house call.






