

THE FIFE COUNCIL (WOODMILL STREET CAR PARKS, DUNFERMLINE) ORDER 2014

The Fife Council ("the Council") in exercise of the powers conferred on them by sections 32, 35 and 124 of and paragraph 27(1) of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police for the Council's area in accordance with paragraph 20(1) of Schedule 9 to the said Act, hereby make the following Order:-

1. This Order may be cited as "The Fife Council (Woodmill Street Car Parks, Dunfermline) Order 2014" and shall come into operation on the 1st of December 2014.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The Fife Council (Waiting and Loading Restrictions and Off-Street Parking Places) (Consolidation) Order 2013 shall be amended as follows:-
 - (1) In Part 3 - Designation and Use of Parking Places - the following entry shall be inserted after Article 4(1) -
 - (1A) Each parking place described in columns 2 to 4 of Schedule 1B is hereby designated as a parking place only for the leaving of such vehicles as are passenger vehicles.
 - (2) In Part 3 - Designation and Use of Parking Places - any references to "Schedules 1 and 2" in Articles 4(3), 4(3A) and 4(4) shall be amended to read "Schedules 1, 1B and 2".
 - (3) The following entries shall be deleted from Schedule 1 – Off-Street Parking Places:
