### (Traffic Management) Order 2008

Glasgow City Council in exercise of the powers conferred on them by the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Strathclyde Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

#### PART 1 - GENERAL

##### Citation and Commencement

1. a) This Order may be cited as the "Glasgow City Council (Scotstoun) (Traffic Management) Order 2008" and shall come into operation on 29 June 2008.
- b) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to an Act of Parliament.
2. The Council is satisfied that for facilitating the passage of vehicular traffic on the roads to which the Order relates it is requisite that Section 3 (1) of the Road Traffic Regulation Act 1984 should not apply to the Order.

##### Interpretation

3. In this Order, the following expressions have the meanings assigned to them:-

**"Administration fee"** means the charge for the replacement of a lost or damaged Resident Parking Permit and Residents' Visitor parking permit;

**"Chief Constable"** means Chief Constable of Strathclyde Police;

**"Council"** means Glasgow City Council;

**"Disabled person's badge"** and **"Relevant position"** have the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (Scotland) Regulations 2002;

**"Emergency services vehicle"** means a vehicle being used for Police, Fire Brigade, Ambulance Services or Civil Defence Organisation purposes;

**"Moped"** has the meaning given by paragraph 5 of Schedule 9 to the Road Vehicles (Construction and Use) Regulations 1986(c);

**"Motorcycle"** has the same meaning as is given to the expression in Regulation (3) (2) of the Road Vehicles (Construction and Use) Regulations 1986;

**"Parking attendant"** means any person authorised by or on behalf of the Council to issue penalty charge notices;

**"Pedal cycle"** means a unicycle, bicycle, tricycle or cycle having four or more wheels, not being in any case mechanically propelled unless it is an electrically assisted pedal cycle of such class as is to be treated as not being a motor vehicle for the purposes of the Road Traffic Regulation Act 1984;

**"Penalty Charge Notice"** means a device containing the information required by the Road Traffic Act 1991, as amended, for a penalty charge notice;

**"Powered Two Wheeler"** means a motorcycle and moped;

“**Relevant event**” means any sporting, social or entertainment event to be held at Scotstoun stadium, including those periods prior to, during and following the event, which has been identified by the Council as requiring traffic management;

“**Resident parking permit**” means a badge or disc issued by the Council, in accordance with the provisions of this Order;

“**Residents’ Visitor parking permit**” means a parking device of a type approved by the Scottish Office and issued by the Council, in accordance with the provisions of this Order;

“**Universal service provider**” has the same meaning as in the Postal Services Act 2000;

“**Vehicle**” unless the context otherwise requires, means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along roads whether by animal or mechanical power;

“**Zone identifier**” means a letter or group of letters identifying an area throughout which parking permits are made available.

#### **PART II – PROHIBITION OF WAITING**

##### **Waiting Restrictions**

4. Save as provided in Article 6 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait at any time in any of the lengths of roads specified in Schedule 1 to this Order.
5. Save as provided in Articles 6 & 7 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait during a relevant event in any of the lengths of roads specified in Schedule 2 to this Order.

##### **Exemptions from Waiting Restrictions**

6. Nothing in Articles 4 & 5 of this Order shall:-
  - (i) prevent any person from causing or permitting a vehicle to wait in the lengths of roads referred to in those Articles:-
    - a) for so long as may be necessary to enable a person to board or alight from the vehicle or to load thereon or unload therefrom his/her personal luggage;
    - b) if the vehicle is an emergency services vehicle;
    - c) if the vehicle is prevented from proceeding by circumstances beyond the driver’s control or which has to be stopped in order to avoid injury or damage to persons or property;
    - d) if the vehicle is a marked vehicle which, whilst used by a universal service provider in the course of the provision of a universal postal service, is stationary only for so long as may be reasonably necessary for postal packets to be delivered or collected;

- (ii) apply to a pedal cycle attached to a stand which displays the sign to Traffic Signs Regulations and General Directions 2002 Diag No. 968;
- (iii) apply to a vehicle which is not causing an obstruction and which displays a disabled person's badge in the relevant position;
- (iv) prevent any person from causing or permitting a vehicle to wait in the lengths of road referred to in that Article for so long as may be necessary for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle at premises adjoining that road provided that:-
  - (a) no such vehicle shall wait for a longer period than 30 minutes in the same place;
  - (b) no such vehicle shall wait for a longer period than 10 minutes in the same place without goods being loaded onto or unloaded from the vehicle.

Notwithstanding anything in the above paragraphs of this Article the driver waiting for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle shall move the same on the instruction of a Police Constable in uniform whenever such moving may be reasonably necessary for the purpose of preventing an obstruction.

7. Nothing in Article 5 of this Order shall:-

- (i) apply to a vehicle left displaying a Resident parking permit or Residents' Visitor parking permit;
- (ii) prevent any person from causing or permitting a vehicle to wait in the lengths of roads specified in Schedule 2 to this Order if the vehicle is a powered two wheeler.

Notwithstanding anything in the above paragraphs of this Article the driver waiting for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle shall move the same on the instruction of a Police Constable in uniform whenever such moving may be reasonably necessary for the purpose of preventing an obstruction.

#### **Movement of vehicle in an emergency**

8. Any person duly authorised by the Council or a police constable in uniform or a parking attendant may move or cause to be moved in case of emergency, to any place they think fit, vehicles left in any of the lengths of road specified in Schedules 1 and 2 to this Order.

Nothing in the foregoing provision of this Article shall be taken as authorising anything which would be a contravention of any Regulations made or having effect as if made under Section 25 of the Road Traffic Regulation Act, 1984.

**PART III - PARKING PERMITS**

**Resident and Residents' Visitor Parking Permits**

- 9.(i) Subject to Articles 10 to 14 inclusive of this Order resident parking permits shall be available for issue to any person who ordinarily resides in a dwellinghouse within the boundary as defined on the plan in Schedule 5.
- (ii) Subject to Articles 10 to 14 inclusive of this Order residents' visitor parking permits shall be available for purchase at the prices specified in Schedule 4 by any person who ordinarily resides in a dwellinghouse within the boundary as defined on the plan in Schedule 5.
- (iii) Each resident and residents' visitor parking permit issued shall incorporate the zone identifier indicated on the plan in Schedule 5.
10. The resident and residents' visitor parking permit shall be displayed on the nearside of the vehicle, behind the glass of the windscreen, in such a position as to ensure that the front side of the permit is clearly visible to any person standing at the front or nearside of the vehicle.
11. Any vehicle which displays a resident or residents' visitor parking permit, in the manner specified in Article 10 of this Order, may be left within any of the lengths of road specified in Schedule 2.
12. As regards the issue of resident and residents' visitor parking permits:-
- (i) application for a resident or residents' visitor parking permit shall be made in a manner determined by the Council and the applicant shall provide such information as the Council may require in order to verify that the issue of a permit will be valid; and
- (ii) the Council, on being satisfied that the applicant has provided the information required in paragraph (i) of this Article, shall issue to the applicant a resident parking permit to be used as defined in Articles 10 and 11.
- (iii) the Council, on being satisfied that the applicant has provided the information required in paragraph (i) of this Article, shall issue to the applicant on payment of the sum detailed in Schedule 4 to this Order a residents' visitor parking permit to be used as defined in Articles 10 and 11.
13. The Council may, giving 28 days notice in writing served on the resident parking permit holder at the address shown on the application for the permit, or at such other address believed to be the resident parking permit holder's residence at the time, withdraw all the holder's resident or residents' visitor parking permits if:-
- (i) the resident parking permit holder ceases to be a resident at the address for which the permit is issued.
- (ii) the Council issues a duplicate or replacement permit under the provision of Article 14 of this Order.
14. A duplicate or replacement resident or residents' visitor parking permit may be issued on application if:-

- (i) a permit is mutilated or defaced or faded so that the identifying mark as referred to in Article 9 (iii) of this Order is illegible when the permit holder shall surrender the permit to the Council and shall apply for issue under paragraph (i) of Article 12, of this Order of a duplicate or replacement permit which, when issued on payment of an administration fee as specified in Schedule 4 to this Order, shall render the original permit invalid; or
  - (ii) a permit is lost or destroyed, when the permit holder may apply to the Council for the issue of a duplicate or replacement permit under paragraph (i) Article 12 of this Order and paragraph (i) of this Article; or
15. The provisions of Articles 9 to 14 inclusive of this Order shall apply equally to a duplicate or replacement resident or residents' visitor parking permit as for an original permit.

#### **PART IV - PENALTY CHARGE**

- 16.(i) A penalty charge shall be payable, with respect to a vehicle if that vehicle is waiting on any length of road specified in Schedules 1 and 2 to this Order otherwise than in accordance with the provisions of this Order.
- (ii) The amount of the penalty charge shall be as specified in Schedule 3 to this Order.
- (iii) A penalty charge notice shall be attached to the vehicle, or handed to the driver of the vehicle, incurring the penalty charge.
17. Where a notice has been attached to a vehicle in accordance with Article 16 (iii) of this Order, no person, not being the driver of the vehicle or a person duly authorised by the Council, shall remove the notice from the vehicle unless authorised to do so by the driver.
18. Where a penalty charge notice has been issued in accordance with Article 16 a parking attendant may remove or cause to be removed vehicles from any of the lengths of road specified in Schedules 1 and 2 to this Order and, where it is so removed, shall provide for the safe custody of the vehicle.

#### **Power to dispose of abandoned vehicles**

19. The Council may as respects a vehicle which has been removed from any of the lengths of road specified in Schedules 1 and 2 to this Order in pursuance with Article 18 of this Order, if it appears to them to have been abandoned, sell or otherwise dispose of the vehicle after having made reasonable enquiry to ascertain the name and address of the owner of the vehicle and to inform the owner of their intention.
