
(CITY CENTRE) (TRAFFIC MANAGEMENT) (AMENDMENT No 1) ORDER 2011

Glasgow City Council in exercise of the powers conferred upon on them by Sections 1, 2, 3, 4, 5, 19, 20, 32, 35, 37, 38, 45, 46, 47, 48, 49, 51, 52 and 53 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Strathclyde Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order.

Citation and Commencement

- a) This Order may be cited as "The Glasgow City Council (City Centre) (Traffic Management) (Amendment No.1) Order 2011" and shall come into operation on 11 September 2011.
 - b) The Order specified in Schedule 1 to this Order shall have the effect subject to the amendments specified in that Schedule.
 - c) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
