THE PERTH AND KINROSS COUNCIL (PITLOCHRY TRAFFIC MANAGEMENT) (VARIATION) (NO 1) ORDER 2011

The Perth and Kinross Council in exercise of the powers conferred on them by Sections 1, (1) and 2, 2(1) to (3), and 4(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (which Act of 1984 is hereinafter referred to as "the Act") and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- 1. This Order may be cited as "the Perth and Kinross Council (Pitlochry Traffic Management) (Variation) (No. 1) Order 2011" and shall come into operation on the Eighth day of March Two thousand and eleven.
- 2. The Perth and Kinross Council (Pitlochry Traffic Management) Order 1998 is hereby varied and shall henceforth have effect subject to the amendments thereto specified and described in the Schedule to this Order.

The Perth and Kinross Council (Pitlochry Traffic Management) Order 1998 requires to be varied as follows:-

In PART III EXEMPTIONS

- 1. At section **Doctors, Disabled Persons, Taxis, Accidents, Etc**In part 7 (b) in line 5 delete "Part VI" and substitute with "Part V".
- At section Goods Delivery and Collection
 In part 8 (b) in line 4 delete "Part VI" and substitute with "Part V".
- At section Furniture Removal
 In part 9 in line 7 delete "Part VI" and substitute with "Part V".

The **SCHEDULE** to the Perth and Kinross Council (Pitlochry Traffic Management) Order 1998 requires to be varied as follows:-

- 4. In PART II NO WAITING AT ANY TIME at section 1 ATHOLL ROAD
 - (b) South side thereof:- at paragraph (i) delete the existing and insert the following;-
 - (i) from a point 9 metres or thereby west of the west side of Ferry Road eastwards to a point 58 metres or thereby west of the extended west kerbline of Newholme Avenue a distance of 155 metres or thereby;
- 5. In PART III WAITING LIMITED TO 30 MINUTES, RETURN PROHIBITED WITHIN 30 MINUTES at section 1 ATHOLL ROAD
 - (b) South side thereof:- at paragraph (i) delete the existing and insert the following;-
 - (i) from the extended west kerbline of Newholme Avenue westwards for a distance of 58 metres or thereby;
