THE PERTH AND KINROSS COUNCIL (PITLOCHRY TRAFFIC
MANAGEMENT) (VARIATION) (NO 2) ORDER 2011

(13/11)

The Perth and Kinross Council in exercise of the powers conferred on them by Sections 1, 2, 3, 4, 32, 35, 44, 45, 46, 49, and 53, and Part IV of Schedule 9 and Schedule 10 to the Road Traffic Regulation Act 1984 (which Act of 1984 is hereinafter referred to as "the Act") and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order may be cited as "The Perth and Kinross Council (Pitlochry Traffic Management) (Variation) (No. 2) Order 2011" and shall come into operation on the Thirteenth day of October Two thousand and eleven.

2. The Perth and Kinross Council (Pitlochry Traffic Management) Order 1998 is hereby varied and shall henceforth have effect subject to the amendments thereto specified and described in the Schedule to this Order.

The Perth and Kinross Council (Pitlochry Traffic Management) Order 1998 requires to be varied as follows:-

1. **In PART I GENERAL PROVISIONS**

Interpretation

Delete the sections "**disabled person**", "**disabled persons badge**" and "**disabled persons vehicle**" in their entirety and substitute with the following:-

"**disabled person**" means a disabled person of a description prescribed by Regulation 4 of the Disabled Persons (Badges for Motor Vehicles) (Scotland) Regulations 2000;

"**disabled persons' badge**" has the meaning assigned to it by Regulation 11 of the Disabled Persons (Badges for Motor Vehicles) (Scotland) Regulations 2000;

"**disabled persons' vehicle**" means a motor vehicle which is displaying a disabled persons badge being used in accordance with the Disabled Persons (Badges for Motor Vehicles) (Scotland) Regulations 2000.

"**disabled persons' parking place**" means an area of a road designated solely for the parking of disabled persons vehicles.

Delete the section "**invalid carriage**" in its entirety.

2. **In Part II PROHIBITIONS AND RESTRICTIONS**

After **Waiting** part 4

Add and insert the following:-

Disabled Persons' Parking Places

- 4A No person shall, except upon the direction or with the permission of a person duly authorised in that behalf by the Council, cause or permit any vehicle other than a disabled persons vehicle to wait at any time in any length of road specified in **PART VI** of the Schedule.

3. **In PART III EXEMPTIONS**

Delete the section 10. **Public Service Bus** in its entirety.

Delete Cycles "11" and Substitute as "10"

The **SCHEDULE** to the Perth and Kinross Council (Pitlochry Traffic Management) Order 1998 requires to be varied as follows:-

4. At **PART III**

WAITING LIMITED TO 30 MINUTES, RETURN PROHIBITED WITHIN 30 MINUTES

At section 1 **ATHOLL ROAD** (b) south side thereof part (ii) delete the existing and substitute with the following:-

from a point 9 metres or thereby west of the west side of Ferry Road westwards to a point 7 metres or thereby east of its junction with Station Lane;

at south side thereof part (v)

In line two after the words to a point delete the number "9" and substitute with "16"

(c) Layby

In line one delete the number "60" and substitute with "46"

5. At **PART IV WAITING LIMITED TO 30 MINUTES, RETURN PROHIBITED WITHIN 30 MINUTES 8.30 AM TO 5.30 PM**

At section 3. **WEST MOULIN ROAD**

In line two delete the number "30" and substitute with "23"

6. After **PART V NO LOADING AT ANY TIME**
Add and insert the following:-

PART VI

DISABLED PERSONS' PARKING PLACE

1 **ATHOLL ROAD**

North side layby thereof situated between 46 and 60 metres or thereby east of West Moulin Road.

South side thereof

- (i) from its junction with Station Lane eastwards for a distance of 7 metres or thereby.
- (ii) from a point 9 metres or thereby east of the east side of Rie Achan Road eastwards for a distance of 7 metres or thereby.

2. **WEST MOULIN ROAD**

West side thereof from a point 37 metres or thereby north of the north kerbline of Atholl Road southwards for a distance of 7 metres or thereby.
