**PERTH AND KINROSS COUNCIL (AUCHTERARDER) (WAITING RESTRICTIONS)
(VARIATION) (NO 4) ORDER 2015
(NO/16/15)**

Perth and Kinross Council in exercise of the powers conferred on them by Sections 1, 2, 3, 4 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (which Act of 1984 is hereinafter referred to as "the Act") and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- 1 This Order may be cited as the "Perth and Kinross Council (Auchterarder) (Waiting Restrictions) (Variation) (No 4) Order 2015" and shall come into operation on the Fourth day of July Two thousand and fifteen.
- 2 The Perth and Kinross Council (Auchterarder) (Waiting Restrictions) Order 1999 is hereby varied and shall henceforth have effect subject to the amendments thereto specified and described in the Schedule to this Order.

SCHEDULE

The Perth and Kinross Council (Auchterarder) (Waiting Restrictions) Order 1999 requires to be varied as follows:-

1. At **PART I, GENERAL PROVISIONS, Interpretation** delete the word "Tayside" where it occurs in the definition of "**Chief Constable**" and insert "Police Scotland".

The Schedule to "The Perth and Kinross Council (Auchterarder) (Waiting Restrictions) Order 1999" requires to be varied as follows:-

2. In **PART I NO WAITING AT ANY TIME**, after **3A. GLENEAGLES HOTEL PRIVATE ACCESS ROADS**, insert the following:-

"3B. COMMUNITY SCHOOL OF AUCHTERARDER ACCESS ROAD

The inner and outer perimeters of the roundabout on the Campus Access Road for their entire circumferences."

3. After **PART II NO WAITING MONDAY TO FRIDAY**, insert the following:-

"PART III DISABLED PERSONS' PARKING PLACE

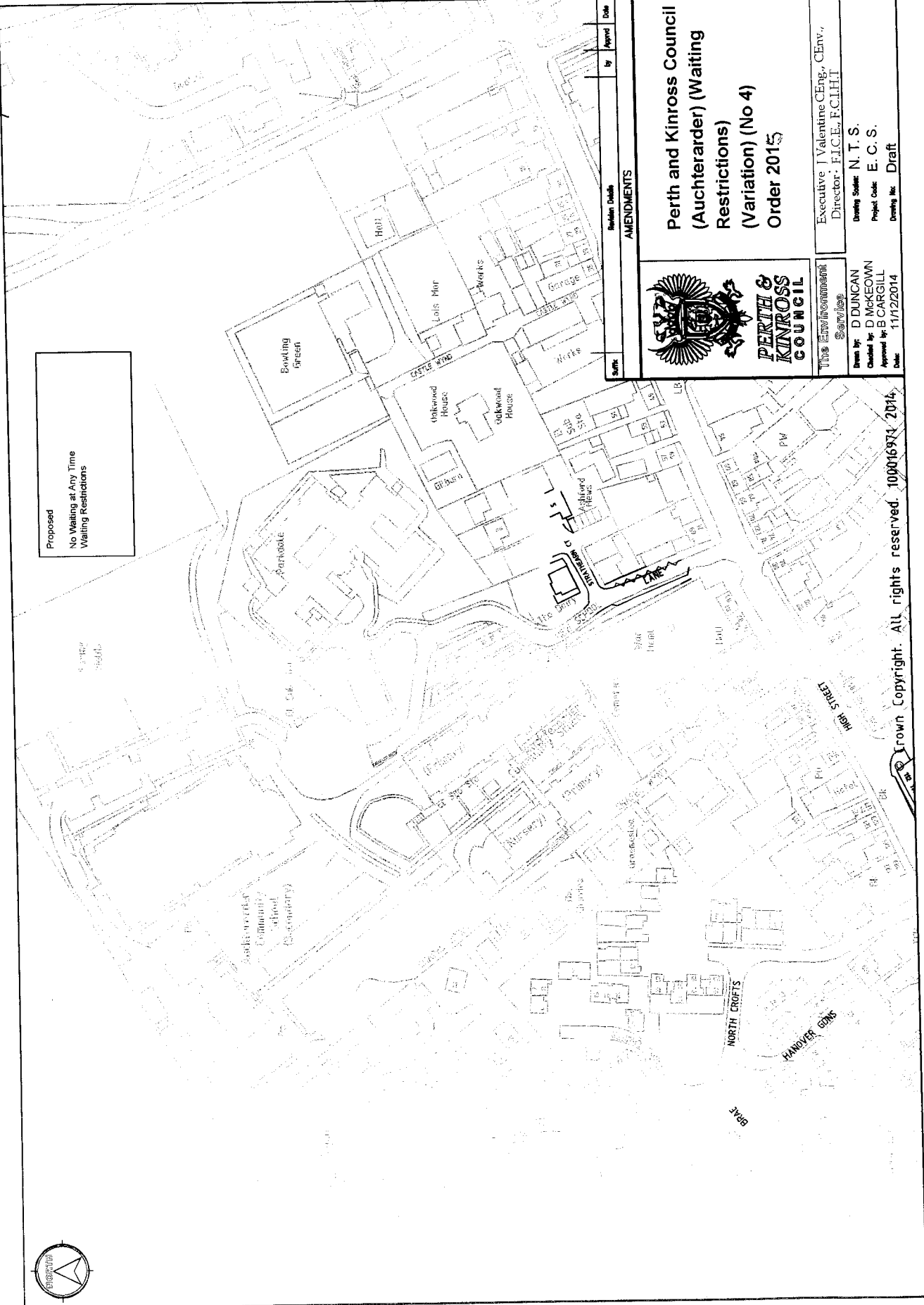
1. THE COMMUNITY SCHOOL OF AUCHTERARDER ACCESS ROAD


West side layby thereof from a point 100 metres or thereby north of its junction with the extended north kerbline of Strathearn Court for a distance of 12 metres or thereby (covering 2 disabled bays)."

Council Reasons

The Council wish to install "no waiting at any time" waiting restrictions at the Access Road to the Community School of Auchterarder in order to alleviate indiscriminate parking at the School Campus and to improve safety of pedestrians and schoolchildren.
