PERTH AND KINROSS COUNCIL **ROAD TRAFFIC REGULATION ACT 1984**

PERTH AND KINROSS COUNCIL (ABERFELDY TRAFFIC MANAGEMENT) (VARIATION) (NO 4) ORDER 2015 (13/15)

The Perth and Kinross Council in exercise of the powers conferred on them by Sections 1, 2, 3, 4, 32, 35, 44, 45, 46, 49, and 53, and Part IV of Schedule 9 and Schedule 10 to the Road Traffic Regulation Act 1984 (which Act of 1984 is hereinafter referred to as "the Act") and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- 1. This Order may be cited as the "Perth and Kinross Council (Aberfeldy Traffic Management) (Variation) (No 4) Order 2015" and shall come into operation on the Twentieth day of May Two thousand and fifteen.
- The Perth and Kinross Council (Aberfeldy Traffic Management) Order 2. 1998 is hereby varied and shall henceforth have effect subject to the amendments thereto specified and described in the Schedule to this Order.

The Perth and Kinross Council (Aberfeldy Traffic Management) Order 1998 requires to be varied as follows:-

1. In PART I GENERAL PROVISIONS

Interpretation

at subparagraph 2.(i) delete the following:

'school bus' means a contract carriage or a vehicle recognised by the Council which is being used to carry persons to or from a school;

2. In PART III PROHIBITIONS AND RESTRICTIONS

Waiting

- (a) at sub paragraph 18 in line one after the number 26 delete "and 26A"
- (b) in sub paragraph 19 in line six after the words "Parts III and IV" add "IVa"

3. In PART IV 'EXEMPTIONS

From Waiting Prohibitions and Restrictions Personal Access, Statutory Undertakings, Funerals

at sub section 20 in line 2 after the words "Parts III and IV" add "IVa"

Doctors, Disabled Persons, Taxis, Accidents, Etc

at sub section 21 in line 2 after the words "Parts III and IV" add "IVa"

Goods Delivery and Collection

at sub section 23 in line 7 after the words "Parts III and IV" add "IVa"

after Public Service Bus sub-section 26

delete (From Stopping and Waiting) and 26A in its entirety.

The Perth and Kinross Council (Aberfeldy Traffic Management) Order Schedule 1998 requires to be varied as follows:-

4. In Part III NO WAITING AT ANY TIME at sub-section

11. HOME STREET

(a) East side thereof:-

In line 1 of sub-paragraph (i) after "for a distance of" delete the number "15" and substitute with "40".

5. In Part IVa NO WAITING (MONDAY TO FRIDAY) (8.30 AM TO 9.30 AM AND 3.00 PM to 4.00 PM)

delete the existing and substitute with the following

ALMA AVENUE

(a) West side from a point 65 metres or thereby south of the intersection of the extended kerbline thereof with the extended south kerbline of Kenmore Street southwards for a distance of 25 metres or thereby.
