# PERTH AND KINROSS COUNCIL (OFF-STREET CAR PARKS) (VARIATION) (NO 6) ORDER 2017 (09/17)

Perth and Kinross Council in exercise of the powers conferred on them by Sections 1, 2, 4, 45, 46, 46A and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (which Act of 1984 is hereinafter referred to as "the Act") and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- 1. This Order may be cited as the "Perth and Kinross Council (Off-Street Car Parks) (Variation) (No 6) Order 2017" and shall come into operation on the Twenty-fifth day of March Two thousand and seventeen.
- 2. The Perth and Kinross Council (Off Street Car Parks) Order 2015 is hereby varied and shall henceforth have effect subject to the amendments thereto specified and described in the Schedule hereto.

## PERTH AND KINROSS COUNCIL (OFF-STREET CAR PARKS) (VARIATION) (NO 6) ORDER 2017

The Perth and Kinross Council (Off-Street Car Park) Order 2015 requires to be varied as follows:-

#### 1. PART I GENERAL PROVISIONS

#### Interpretation

2. after "electric charging vehicles"

Add and insert the following "free car park ticket" means that a ticket must be obtained and displayed from the ticket issuing machine provided where a maximum length of stay is indicated.

At "ticket issuing machine" at the end of the description add the following "or (c) the period in respect of which has been obtained for a free car park and the time the ticket was obtained.

#### 2. At PART III CHARGES

#### **Indications by Tickets**

At section 11 after (3) add and insert the following

(4) The expiry of a free parking period shall be indicated when there is exhibited on the vehicle a ticket issued in terms of paragraph (i) hereof and the time shown on the clock on the ticket issuing machine from which the said ticket was issued indicate or indicates the free parking period obtained has elapsed.

#### 12 Indications by Ticket Issuing Machines and Tickets as Evidence

Add and insert the following

(4) If at any time while a vehicle is left in a car park during the free maximum stay period no ticket is exhibited on that vehicle in accordance with the provisions of paragraph (1) of the last preceding Article is shall be presumed, unless the contrary is proved, that a free parking ticket has not been obtained.

The **SCHEDULE** to the Perth and Kinross Council (Off-Street Car Park) Order 2015 requires to be varied as follows:-

#### At 8 CRIEFF FREE CAR PARKS

(a) King Street/Galvelmore Street

At column 8 Maximum Charging Period delete the existing Max stay 2 hours and insert Max stay 3 hours

### **Council Reasons**

Perth and Kinross Council wish to vary the Off Street Car Park Order to include a reference which explains the reasons why a ticket which must be obtained and displayed on any parked vehicle using the free maximum stay period at King Street, Galvelmore Street car park in Crieff. The Council also wish to amend the length of the free stay period from 2 hours to 3 hours.
