THE PERTH AND KINROSS COUNCIL ROAD TRAFFIC REGULATION ACT 1984

PERTH AND KINROSS COUNCIL (OFF-STREET CAR PARKS) (VARIATION) (NO 2) ORDER 2015 (NO. 17/15)

Perth and Kinross Council in exercise of the powers conferred on them by Section 35(1) and (3) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (which Act of 1984 is hereinafter referred to as "the Act") and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- 1. This Order may be cited as the "Perth and Kinross Council (Off-Street Car Parks) (Variation) (No 2) Order 2015 and shall come into operation on the Tenth day of July Two thousand and fifteen.
- 2. The Perth and Kinross Council (Off Street Car Parks) Order 2015 is hereby varied and shall henceforth have effect subject to the amendments thereto specified and described in the Schedule hereto.

SCHEDULE

The Schedule to the Perth and Kinross Council (Off-Street Car Parks) Order 2015 requires to be varied as follows:-

GENERAL PROVISIONS

Interpretation 2

- 1. At "Car Park" after paragraph 1 add and insert the following:
 - and where a charge is levied the following descriptions apply:-
 - (a) a "pay and display car park" is a car park where a ticket is issued from a ticket issuing machine and displayed on the vehicle for the duration of its stay.
 - (b) a "pay before exiting car park" also known as pay on foot is a car park where a ticket is issued from a ticket issuing machine upon entry and payment is made at the "Pay Station" for the parking time used before exiting the car park.
- 2. After "passenger vehicle" add and insert the following:-
 - "Pay Station" means apparatus designed to accept the required payment of a charge, in respect of the time a vehicle is left in the car park.
- 3. At "POE" add and insert the following:-
 - "PBE" (Pay Before Exit) means taking a ticket upon entry from a ticket issuing machine relating to the car park in which the vehicle is to be left and paying for the time used at the "Pay Station" before exiting the said car park.

4. At PART III CHARGES

Parking Charge- Amount and Method of Payment and Display of Tickets

At subsection 6.(3) The parking charge shall be paid either:-

After (b) add and insert the following:-

(c) or by the insertion of notes or cash or credit/debit card in a "Pay Station" machine situated in a car park in which the vehicle has been left.

Indications by Tickets

After paragraph 11.(3) add and insert the following:-

(4) In a pay before exit car park the numbered ticket issued on entry by a ticket issuing machine shall indicate the day and time of entry of the vehicle into the said car park.

5. SCHEDULE

The Schedule to the Perth & Kinross Council (Off-Street Car Parks) Order 2015 requires to be varied as follows:-

The following note requires to be added to each footer page at Explanatory notes:-

"PBE" (Pay Before Exit) means taking a ticket upon entry from a ticket issuing machine relating to the car park in which the vehicle is to be left and paying for the time used at the "Pay Station" before exiting the said car park.

COUNCIL REASONS

Perth and Kinross Council wish to remove the South Inch Car Park from the existing Pay & Display payment system and replace this with a Pay On Exit (also known as Pay on Foot) payment system. It is believed that this will lead to a more customer friendly method of paying for parking.
