South Ayrshire Council in exercise of the powers conferred on it by Sections 1(1) c, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended, and the Road Traffic Act 1991 and of all other enabling powers, and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

Citation and commencement

1. This Order may be cited as the "South Ayrshire Council (Various Streets, Troon) (Limited Waiting Restrictions Amendment) Order 2015" and shall come into operation on Monday 18th May 2015.

Interpretation

2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to an Act of Parliament.

Amendments

4. The Orders specified in the Schedule annexed and executed as relative to this Order shall have effect subject to the amendments specified in that Schedule.



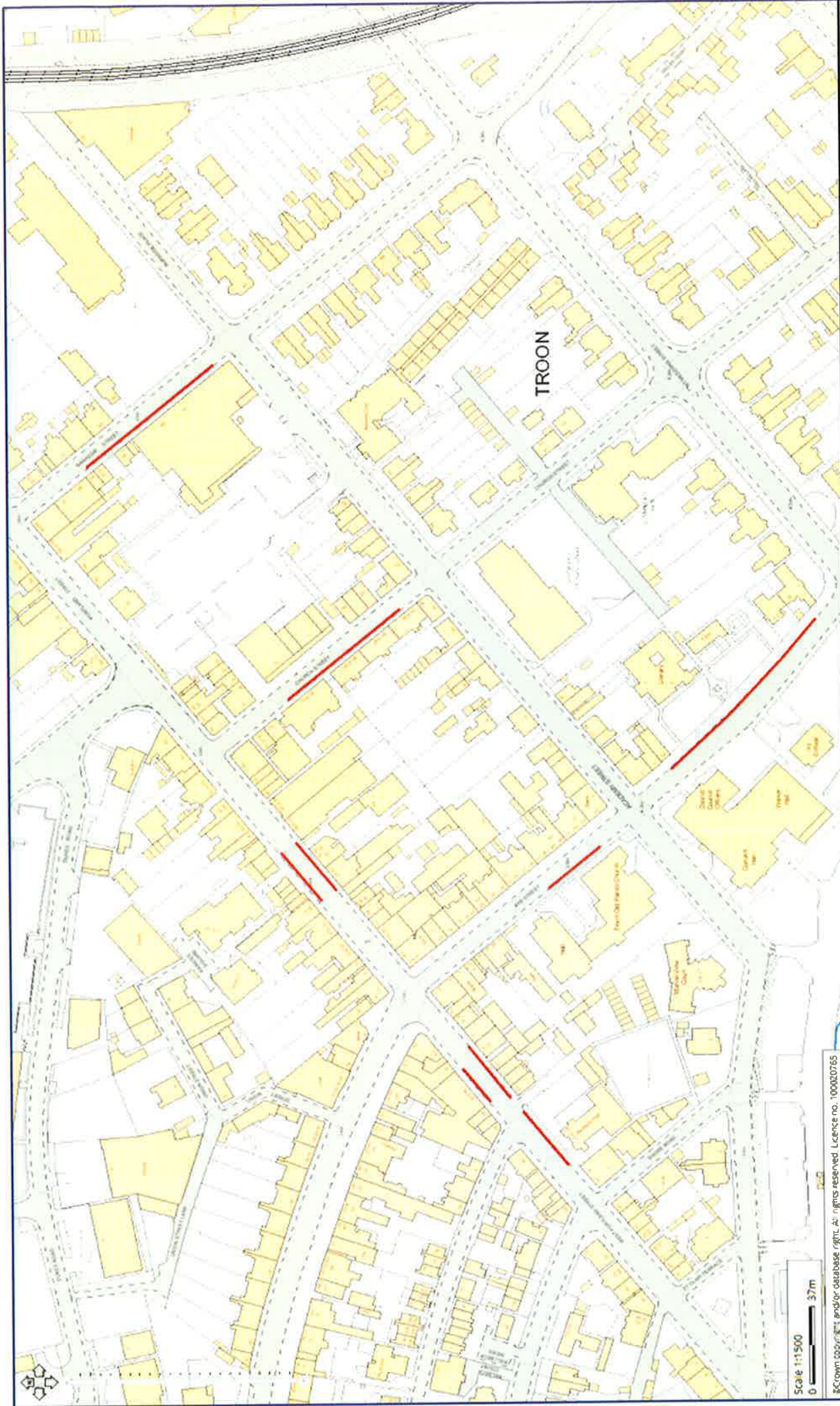
