South Ayrshire Council in exercise of the powers conferred on it by Sections 1(1)c, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended, and the Road Traffic Act 1991 and of all other enabling powers, and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

Citation and commencement

1. This Order may be cited as the "South Ayrshire Council (Main Street, Prestwick) (Limited Waiting Restrictions Amendment) Order 2015" and shall come into operation on Monday 1st June 2015.

Interpretation

2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to an Act of Parliament.

Amendments

4. The Order specified in the Schedule annexed and executed as relative to this Order shall have effect subject to the amendments specified in that Schedule.

Insert the following Article pertaining to **Schedule 10a** :-

42. Save as provided in Articles 20, 21 & 22 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a parking attendant in uniform, cause or permit any vehicle to wait between the hours of 8.00am and 6.00pm, Monday to Saturday inclusive, in any of the areas of roads specified in Column 2 of Schedule 10a to this Order –
- (a) for a longer period than 2 hours; or
 - (b) if a period of less than 60 minutes has elapsed since the last period of waiting of the vehicle in the same parking place.

In Article 20 for the words “Nothing in Articles 18 and 19 of this Order shall”

There shall be substituted the words “Nothing in Articles 18, 19 and 42 of this Order shall”

In Article 21 for the words “Nothing in Articles 18 and 19 of this Order shall”

There shall be substituted the words “Nothing in Articles 18, 19 and 42 of this Order shall”

In Article 22 for the words “Nothing in Articles 18 and 19 of this Order shall”

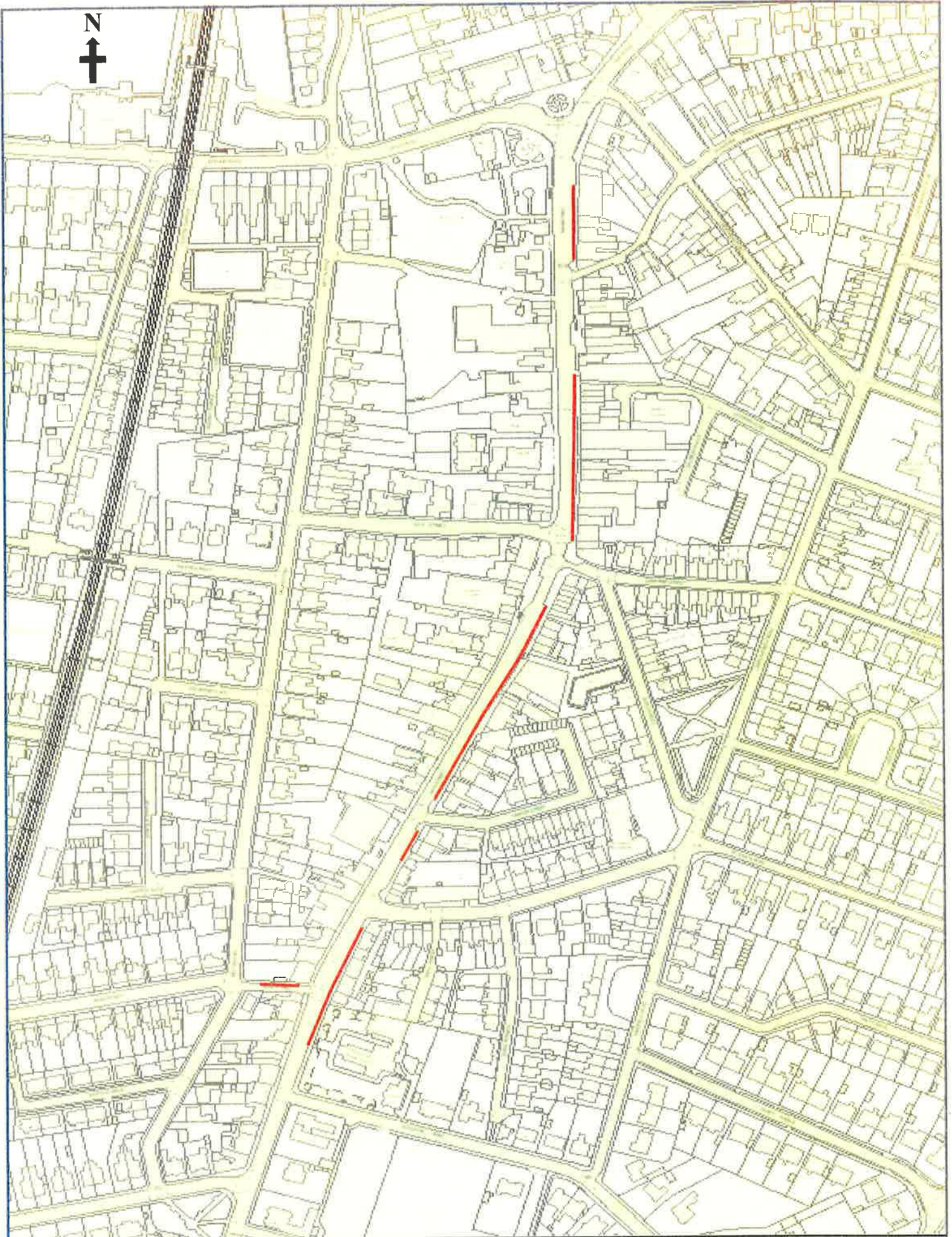
