CONSOLIDATION ORDER 2005, AMENDMENT NO. 1
ORDER 2007**

South Lanarkshire Council, in exercise of the powers conferred on them by Sections 84 of the Road Traffic Regulation Act 1984 ("the act") and of all other enabling powers, and after consultation with the Chief Constable of Strathclyde Police in accordance with Part III of schedule 9 to the Act, hereby make the following Order:
