

**SOUTH LANARKSHIRE COUNCIL  
(HAMILTON TOWN CENTRE)  
(TRAFFIC MANAGEMENT)  
ORDER 1998 .**

South Lanarkshire Council in exercise of the powers conferred on them by Sections 1(1), 2(1) to (3), 82(2), 83(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Strathclyde Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order.

1. This Order may be cited as "SOUTH LANARKSHIRE COUNCIL (HAMILTON TOWN CENTRE) (TRAFFIC MANAGEMENT) Order 1998" and shall come into operation on 4th day of May, Nineteen Hundred and Ninety Eight.

2. In this Order the following expressions have the meanings hereby assigned to them:-

"vehicle" unless the context otherwise requires, means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along roads whether or not by mechanical power;

"taxi" has the same meaning as in Section 23(1) of the Civic Government (Scotland) Act 1982;

"private hire car" has the same meaning as in Section 23(1) of the Civic Government (Scotland) Act 1982;

"disabled person's badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) Regulations 1982 as amended;

"disabled person's vehicle" has the same meaning as in The Local Authorities Traffic Orders (Exemptions for Disabled Persons) (Scotland) Regulations 1991;

"emergency service vehicle" means a vehicle being used by the Police, Fire Brigade or Ambulance Services;

"local authority" means South Lanarkshire Council;

"Council" means South Lanarkshire Council;

"goods vehicle" means a vehicle constructed or adapted for the use of the conveyance of goods or burden of any description but not including a dual-purpose vehicle;

**"public service vehicle"** has the same meaning as in the Public Passenger Vehicles Act 1981;

**"buses"** means, (i) motor vehicles constructed or adapted to carry more than 8 passengers (exclusive of the driver), and (ii) local buses not so constructed or adapted;

**"local service"** has the same meaning as in the Transport Act 1985;

**"telecommunications apparatus"** is as defined in the Telecommunications Act 1984;

**"goods"** includes postal packets of any description and **"delivering"** and **"collecting"** in relation to any goods includes checking the goods for the purpose of their delivery or collection;

**"permit"** means a permit issued by an authorised officer of the Council;

**"Heavy Commercial Vehicle"** has the same meaning as in Section 138 Paragraph (1) of the Road Traffic Regulation Act 1984;

**"public service vehicle"** has the same meaning as defined in the Public Passenger Vehicles Act 1981;

**"The Motherwell Road Roundabout, Hamilton"** is the roundabout situated at the junction of Motherwell Road (A723)/ Blackswell Lane (A723) / Keith Street / realigned section of Motherwell Road (A72), Hamilton;

**"The Mote Hill Roundabout, Hamilton"** is the roundabout situated at the junction of Muir Street (A72) / Mote Hill / Castle Street / realigned section of Motherwell Road (A72), Hamilton.

**"Parking Attendant"** shall have the same meaning as defined in Section 63A of the Road Traffic Regulation Act 1984.

3. No Waiting and No Loading at any time

Save as provided in Article 15 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait at any time in any of the lengths of roads specified in Schedule 1 to this Order.

4. No Waiting at any time

Save as provided in Articles 15 & 17 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait at any time in any of the length of road specified in Schedule 2 to this Order.

5. No Waiting between certain hours

Save as provided in Articles 15 & 17 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait between 08:00 hrs to 21:00 hrs all week, in any of the lengths of roads specified in Schedule 3 to this Order.

6. No Waiting between certain hours

Save as provided in Articles 15, 16 & 17 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait between 08:00 hrs to 18:00 hrs Monday to Saturday inclusive, in any of the lengths of roads specified in Schedule 4 to this Order.

7. No Loading between certain hours

Nothing in Article 15 of this order shall prevent any person from causing or permitting to wait between 08:00 hrs to 09:00 hrs and 16:30 hrs to 17:30 hrs Monday to Saturday inclusive, in any of the lengths of roads specified in Schedule 5 to this Order.

8. Prohibition of Entry

No person shall drive or cause or permit to be driven any vehicle from any of the roads specified in Column 1 of Schedule 6 to this Order so as to enter the road "opposite to such road" in the same line of Column 2 of the said Schedule 6.

9. One Way Operation

No person shall drive or cause or permit to be driven any vehicle on the length of road specified in Column 1 of Schedule 7 to this Order otherwise than in the directions specified in Column 2 of the said Schedule 7.

10. Prohibition of Right Hand Turn

No person shall drive or cause or permit to be driven any vehicle on the road specified in Column 1 of Schedule 8 to this Order so as to make a right-hand turn into the road specified "opposite to such road" in Column 2 of the said Schedule 8.

11. Prohibition of U-Turn

No person shall drive or cause or permit to be driven any vehicle proceeding on the lengths of roads specified in Column 1 of Schedule 9 to this Order to about-turn so as to directly proceed in the opposite direction in the lengths of roads specified "opposite to such road" in Column 2 of the said Schedule 9.

12. Bus Stop Clearway (No stopping with the exception of buses)

No person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle, other than buses providing a local service, to stop between 06.00 hrs and 23.00 hrs all week, in any of the lengths of roads specified in Schedule 10 to this Order.

Nothing in the above Article shall apply:-

(a) so as to prevent any vehicle waiting in the said lengths of road for so long as may be necessary to enable the vehicle, if it cannot be used for such purpose without so waiting, to be used in connection with any building operation or demolition being carried on adjacent thereto, the removal of any obstruction or potential obstruction to traffic, the maintenance, testing, alteration, repair or removal of any structure, works, or apparatus in, on, under or over the road;

(b) to an emergency services vehicle;

(c) to a vehicle being used in the service of the local authority or with the permission of the local authority in exercise of statutory powers and duties if it is necessary for the vehicle while being so used to wait in the said lengths of road;

(d) to a vehicle waiting in any case where the person in control of the vehicle:-

- (i) is required by law to stop;
- (ii) is obliged to do so in order to avoid an accident;
- (iii) is prevented from proceeding by circumstances outwith his control and it is not reasonably practicable for him/her to drive or move the vehicle to a place not within the said lengths of road.

13. Speed Restriction

That length of road specified in Schedule 11 to this order shall become a restricted road for the purposes of Section 81(1) of the Act, which imposes a speed limit of 30 miles per hour on a restricted road.

14. No access except for certain vehicles

Save as provided in Article 20 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, drive or cause or permit to be driven any vehicle between 08:00 hrs to 18:00 hrs all week, in the length of road in Schedule 12 to this Order.

15. Waiting Restriction Exemptions

Nothing in Articles 3, 4, 5, & 7 of this Order shall:-

(a) prevent any person from causing or permitting a vehicle to wait in any of the lengths of the roads referred to in those Articles:-

- (i) for so long as may be necessary to enable a person to board or alight from the vehicle or to load thereon or unload therefrom his personal luggage;
- (ii) for so long as may be necessary to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of the roads so referred to, or the laying, erection, alteration or repair in or near to any of the said lengths of the roads, of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus;

- (iii) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of statutory powers and duties and in particular, but without prejudice to the generality of the foregoing, to enable the vehicle to be used in connection with police, fire brigade and ambulance purposes;
- (iv) if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid an accident;
- (v) if the vehicle is in the service of or employed by the Post Office and is waiting in any of the lengths of the roads while postal packets addressed to premises adjacent thereto are being unloaded from the vehicle or having been unloaded therefrom are being delivered or while postal packets are being collected from premises or posting boxes adjacent thereto;
- (vi) for the purpose of loading or unloading the vehicle while the vehicle is standing at the kerb and in actual use in connection with the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository;
- (vii) to enable the vehicle to be used in connection with funeral and bridal operations.

(b) apply to a licensed taxi waiting in a taxi stance during any period for which that stance has been designated by the Council under the Civic Government (Scotland) Act 1982.

#### 16. Disabled Exemptions

(a) Nothing in Articles 4, 5 and 6 of this Order shall apply to any disabled person's vehicle which is not causing an obstruction and which displays a disabled person's badge issued by a local authority in exercise of its powers under Section 21 of the Chronically Sick and Disabled Persons Act 1970.

#### 17. Waiting / Loading Exemptions

Nothing in Articles 5 & 6 of this Order shall prevent any person from causing or permitting a vehicle to wait in the lengths of road referred to in those Articles;

(a) for so long as may be necessary for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle at premises adjoining that road

provided that no vehicle engaged in delivering or collecting goods or merchandise or being loaded or unloaded shall wait for a longer period than thirty minutes in the same place and no such vehicle shall wait for a longer period than ten minutes in the same place without goods being loaded onto or unloaded from the vehicle;

- (i) Provided that no such vehicle shall wait between 08:00 hrs to 21:00 hrs all week, on any lengths of road specified in Schedule 3 of this Order;
- (ii) Provided that no such vehicle shall wait between 08:00 hrs to 18:00 hrs Monday to Saturday inclusive, on any lengths of road specified in Schedule 4 of this Order;
- (iii) Provided that no such vehicle shall wait between 08:00 hrs to 09:00 hrs and 16:30 hrs to 17:30 hrs Monday to Saturday, on any lengths of road specified in Schedule 5 of this Order.

(b) notwithstanding anything in paragraph (a) of this Article the driver waiting for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle shall move the same on the instruction of a police constable in uniform whenever such moving may be reasonably necessary for the purpose of preventing an obstruction.

#### 18. Amendments

The Orders specified in Schedule 13 to this Order shall have effect subject to the amendments specified in that Schedule.

#### 19. Revocations

The Orders specified in Schedule 14 to this Order are hereby revoked.

#### 20. Access Exemptions

Nothing in Article 14 of this Order shall apply so as to prevent a vehicle from being driven in the length of road in Schedule 12 to this Order provided that:-

- (i) the bus is providing a local service; or
- (ii) the vehicle is a hand cart or barrow or an electrically or mechanically propelled vehicle which is under the control of a pedestrian and is being used for the purpose of delivering or collecting goods to or from premises adjoining the restricted road or accessible from and only from that road; or

- (iii) the vehicle is in the service of the Post Office and is delivering or collecting postal packets at premises or posting boxes adjoining the said restricted road or at premises or posting boxes accessible only from that road; or
- (iv) the vehicle is a heavy commercial vehicle delivering or collecting goods or merchandise or loading or unloading the vehicle at premises adjoining the said road or accessible from that road providing that no vehicle shall;
  - (a) wait for a longer period than thirty minutes; or
  - (b) return if a period of less than thirty minutes has elapsed since the termination during the said hours of the last period of waiting of the vehicle in the road; or
  - (c) wait for a longer period than ten minutes at the same place without goods being loaded onto or unloaded from the vehicle; or
- (v) the driver of the vehicle has a permit as provided for in Article 21 hereof and issued by an officer authorised by the Council indicating that the vehicle is authorised to be used in the said road; or
- (vi) the vehicle is being used in pursuance of statutory powers and duties and in particular, but without prejudice to the generality of the foregoing, it is being used in connection with police, fire brigade or ambulance purposes; or
- (vii) the vehicle cannot conveniently be used for such purpose in any other road and is being used in the restricted road in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the road or the laying, erection, alteration, maintenance or repair in or adjacent to the said restricted road of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line or street lighting apparatus or any traffic sign or parking meter; or
- (viii) the vehicle is in actual use in connection with the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository; or
- (ix) the vehicle is being used in connection with funeral operations or for bridal purposes; or
- (x) the taxi or private hire car is being used as such.



## 21. Permit Conditions

- (i) Issue and re-issue of permits shall be by an authorised officer of the Council.
- (ii) Each permit will relate to one vehicle or company or resident and permits will only be issued to occupiers of businesses and residents on Cadzow Street or accessing their properties directly from Cadzow Street or any other person / body who can give justification for requiring entry to that street.
- (iii) The number of permits issued to any one person or body will be at the discretion of an authorised officer of the Council.
- (iv) Permits will be renewed annually or any time period designated by the Council on request by the holder provided he / she has conformed to the conditions as laid down by the Council. The expired permit must be surrendered before a new permit will be issued.
- (v) Any alteration to the Company name or vehicle registration covered by the permit must be reported as soon as possible by letter or in person to the authorised officer of the Council in order that satisfactory arrangements can be made.
- (vi) The permit is the property of and must be returned to the authorised officer of the Council when the holder vacates his / her premises. The permit is not transferable.
- (ix) The loss or theft of a permit should immediately be reported to the authorised officer of the Council.
- (x) In the event of any breach of any of the aforementioned conditions the permit relating to the offending vehicle or company or resident may be withdrawn.

## 22. Enforcement by Parking Attendants

In the event of the Secretary of State for Scotland making an Order under Schedule 3 of the Road Traffic Act 1991 designating certain areas of the local authority area of South Lanarkshire as permitted or special parking areas, parking attendants shall be empowered under Section 43 and Schedule 3 of the said Act to fix penalty charge notice to any vehicle which is stationary in any permitted or special parking area in circumstances in which an offence would have been committed with respect to the vehicle but for paragraph 1 or (the case may be) paragraph 2 of said Schedule 3 and such other powers as the Secretary of State for Scotland may confer in such Order.

23. End Clause (closing paragraph).
