

**SOUTH LANARKSHIRE COUNCIL
(VARIOUS STREETS, EAST KILBRIDE)
(TRAFFIC MANAGEMENT AND REVOCATION)**

ORDER 1998.

South Lanarkshire Council in exercise of the powers conferred on them by Sections 1(1), 2(1) to (3), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Strathclyde Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order.

1. This Order may be cited as "SOUTH LANARKSHIRE COUNCIL (VARIOUS STREETS, EAST KILBRIDE) (TRAFFIC MANAGEMENT AND REVOCATION) Order 1998" and shall come into operation on Eleventh day of November 1998

2. In this Order the following expressions have the meanings hereby assigned to them:-

"**vehicle**" unless the context otherwise requires, means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along roads whether or not by mechanical power;

"**taxi**" has the same meaning as in Section 23(1) of the Civic Government (Scotland) Act 1982;

"**private hire car**" has the same meaning as in Section 23(1) of the Civic Government (Scotland) Act 1982;

"**disabled person's badge**" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) Regulations 1982 as amended;

"**disabled person's vehicle**" has the same meaning as in The Local Authorities Traffic Orders (Exemptions for Disabled Persons) (Scotland) Regulations 1991;

"**emergency service vehicle**" means a vehicle being used by the Police, Fire Brigade or Ambulance Services;

"**local authority**" means South Lanarkshire Council;

"**Council**" means South Lanarkshire Council;

"**goods vehicle**" means a vehicle constructed or adapted for the use of the conveyance of goods or burden of any description but not including a dual-purpose vehicle;

"public service vehicle" has the same meaning as in the Public Passenger Vehicles Act 1981;

"buses" means, (i) motor vehicles constructed or adapted to carry more than 8 passengers (exclusive of the driver), and (ii) local buses not so constructed or adapted;

"local service" has the same meaning as in the Transport Act 1985;

"telecommunications apparatus" is as defined in the Telecommunications Act 1984;

"goods" includes postal packets of any description and "delivering" and "collecting" in relation to any goods includes checking the goods for the purpose of their delivery or collection;

"permit" means a permit issued by an authorised officer of the Council;

"Heavy Commercial Vehicle" has the same meaning as in Section 138 Paragraph (1) of the Road Traffic Regulation Act 1984;

"public service vehicle" has the same meaning as defined in the Public Passenger Vehicles Act 1981;

3. No Waiting at any time

Save as provided in Article 18 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait at any time in any of the length of road specified in Schedule 1 to this Order.

4. No Waiting between certain hours

Save as provided in Articles 18, 19, 20 & 23 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait between 08:00 hrs to 18:00 hrs All Week, in any of the lengths of roads specified in Schedule 2 to this Order.

5. No Waiting between certain hours

Save as provided in Articles 18, 19, & 20 of this Order no person other than those displaying a valid residents parking permit shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait between 08:00 hrs to 18:00 hrs, all week (ie Monday to Sunday inclusive), in any of the lengths of roads specified in Schedule 3 to this Order.

6. Designated Parking Places for Disabled Persons Vehicles

The length of road described in Schedule 4 to this Order shall only be used subject to the provisions of this Order for the leaving of disabled person's vehicles displaying a disabled person's badge.

7. Designated Parking Places For Vehicles Displaying an Orange Badge Issued to an Institution

The length of road described in Schedule 5 to this Order shall only be used subject to the provisions of this Order for the leaving of disabled person's vehicles displaying a disabled person's badge issued to an Institution.

8. Waiting Limited to certain lengths of Time

Save as provided in Article 18, 19 & 20 of this Order, no person shall except upon the direction of a police constable in uniform cause or permit any vehicle to wait between 08:00 hrs to 18:00 hrs All Week,inclusive in any lengths of road specified in Schedule 6

to this Order (a) for a period longer than thirty minutes in the same place; and (b) if a period of less than one hour has elapsed since the termination during the said hours of the last period of waiting of the vehicle on the said length of road.

9. No Loading at any time

Save as provided in Article 18 of this Order no person, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait at Any Time, in any of the lengths of roads specified in Schedule 7 to this Order.

10. No Loading between certain hours

Save as provided in Article 18 of this Order no person, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait between 08:00 hrs and 18:00 hrs All Week, in any of the lengths of roads specified in Schedule 8 to this Order.

11. Prohibition of Entry Except For Vehicles Requiring Access For Loading

No person shall drive or cause or permit to be driven any vehicle with the exception of vehicles requiring access for loading purposes, from any of the roads specified in Column 1 of Schedule 9 to this Order so as to enter the road "opposite to such road" in the same line of Column 2 of the said Schedule.

12. Prohibition of Entry

No person shall drive or cause or permit to be driven any vehicle with the exception of vehicles requiring access for loading purposes, from any of the roads specified in Column 1 of Schedule 10 to this Order so as to enter the road "opposite to such road" in the same line of Column 2 of the said Schedule.

13. Prohibition of Right Hand Turn

No person shall drive or cause or permit to be driven any vehicle on the road specified in Column 1 of Schedule 11 to this Order so as to make a right-turn into the road specified "opposite to such road" in Column 2 of the said Schedule 11.

14. Prohibition of U Turns

No person shall drive or cause or permit to be driven any vehicle proceeding on the lengths of roads specified in Schedule 12 to the Order to about-turn so as to directly proceed in the opposite direction in the same lengths of road specified in the said Schedule 12.

15. One Way Operation

No person shall drive or cause or permit to be driven any vehicle on the length of road specified in Column 1 of Schedule 13 to this Order otherwise than in the directions specified in Column 2 of the said Schedule 13.

16. Prohibition of Driving

No person shall drive or cause or permit to be driven any vehicle on the road specified in Schedule 14 to this Order.

17. Bus Stop Clearway (No stopping with the exception of buses)

No person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle, other than buses providing a local service, to stop between 06.00 hrs and 23.00 hrs all week, in any of the lengths of roads specified in Schedule 15 to this Order.

Nothing in the above Article shall apply:-

(a) so as to prevent any vehicle waiting in the said lengths of road for so long as may be necessary to enable the vehicle, if it cannot be used for such purpose without so waiting, to be used in connection with any building operation or demolition being carried on adjacent thereto, the removal of any obstruction or potential obstruction to traffic, the maintenance, testing, alteration, repair or removal of any structure, works, or apparatus in, on, under or over the road;

(b) to an emergency services vehicle;

(c) to a vehicle being used in the service of the local authority or with the permission of the local authority in exercise of statutory powers and duties if it is necessary for the vehicle while being so used to wait in the said lengths of road;

(d) to a vehicle waiting in any case where the person in control of the vehicle:-

- (i) is required by law to stop;
- (ii) is obliged to do so in order to avoid an accident;
- (iii) is prevented from proceeding by circumstances outwith his control and it is not reasonably practicable for him to drive or move the vehicle to a place not within the said lengths of road.

18. Waiting and Loading Restriction Exemptions

Nothing in Articles 3, 4, 5, 8 & 9 of this Order shall:-

(a) prevent any person from causing or permitting a vehicle to wait in any of the lengths of the roads referred to in those Articles:-

- (i) for so long as may be necessary to enable a person to board or alight from the vehicle or to load thereon or unload therefrom his personal luggage;
- (ii) for so long as may be necessary to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of the roads so referred to, or the laying, erection, alteration or repair in or near to any of the said lengths of the roads, of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus;
- (iii) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of statutory powers and duties and in particular, but without prejudice to the generality of the foregoing, to enable the vehicle to be used in connection with police, fire brigade and ambulance purposes;
- (iv) if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid an accident;
- (v) if the vehicle is in the service of or employed by the Post Office and is waiting in any of the lengths of the roads while postal packets addressed to premises adjacent thereto are being unloaded from the vehicle or having been unloaded therefrom are being delivered or while postal packets are being collected from premises or posting boxes adjacent thereto;

(vi) for the purpose of loading or unloading the vehicle while the vehicle is standing at the kerb and is in actual use in connection with the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository;

(vii) to enable the vehicle to be used in connection with funeral and bridal operations.

(b) apply to a licensed taxi waiting in a taxi stance during any period for which that stance has been designated by the Council under the Civic Government (Scotland) Act 1982.

19. Disabled Exemptions

Nothing in Article 4, 5, 6 & 8 of this Order shall apply to any disabled person's vehicle which is not causing an obstruction and which displays a disabled person's badge issued by a local authority in exercise of its powers under Section 21 of the Chronically Sick and Disabled Persons Act 1970.

20. Waiting / Loading Exemptions

Nothing in Articles 4, 5, 6 & 8 of this Order shall prevent any person from causing or permitting a vehicle to wait in the lengths of road referred to in those Articles;

(a) for so long as may be necessary for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle at premises adjoining that road provided that no vehicle engaged in delivering or collecting goods or merchandise or being loaded or unloaded shall wait for a longer period than thirty minutes in the same place and no such vehicle shall wait for a longer period than ten minutes in the same place without goods being loaded onto or unloaded from the vehicle;

(b) notwithstanding anything in paragraph (a) of this Article the driver waiting for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle shall move the same on the instruction of a police constable in uniform whenever such moving may be reasonably necessary for the purpose of preventing an obstruction.

21. Revocations

The Orders specified in Schedule 16 to this Order are hereby revoked.

22. Permit Conditions

- (i) Issue and re-issue of permits shall be by an authorised officer of the Council.
- (ii) The number of permits issued to any one person or body will be at the discretion of an authorised officer of the Council.
- (iii) Permits will be renewed annually or any time period designated by the Council on request by the holder provided he / she has conformed to the conditions as laid down by the Council. The expired permit must be surrendered before a new permit will be issued.
- (iv) The permit is the property of and must be returned to the authorised officer of the Council when the holder vacates his / her premises or on request by the Council. The permit is not transferable and must only be used during bona-fide visits to the property issued with the permit of a social or domestic nature.
- (v) The loss or theft of a permit should immediately be reported to the authorised officer of the Council.
- (vi) The permit is only valid in the Zone named on the permit.
- (vii) The residents parking permit shall be displayed on the nearside of the vehicle, behind the glass of the windscreen, in such a position as to ensure that the front side of the permit is clearly visible to any person standing at the front or nearside of the vehicle.
- (viii) Vehicles displaying a permit must park on-street in accordance with the contents of the Highway Code.
- (ix) In the event of any breach of any of the aforementioned conditions the permit relating to the offending vehicle or company or resident may be withdrawn.

23. Parking Places Exemption

Nothing in Articles 4 of this Order shall prevent any person from causing or permitting a vehicle to wait in any of the lengths of the roads referred to in Schedule 2 to this Order provided the vehicle is waiting in a designated parking place where the limits of each parking place and the limits of each parking bay in the parking place shall be indicated on the carriageway in such a manner as the Council may determine by lines or other indications and designated by Order by the Council under Section 32 (1) the Road Traffic Regulation Act 1984.

24. End Clause (closing paragraph).
