

**SOUTH LANARKSHIRE COUNCIL  
(RUTHERGLEN TOWN CENTRE)  
(TRAFFIC MANAGEMENT AND REVOCATION) ORDER 2001**

South Lanarkshire Council in exercise of the powers conferred on them by Sections 1(1), 2(1) to (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Strathclyde Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order.

1. This Order may be cited as "South Lanarkshire Council (Rutherglen Town Centre) (Traffic Management and Revocation) Order 2001" and shall come into operation on 28<sup>th</sup> February 2003.

2. In this Order the following expressions have the meanings hereby assigned to them:-

"**vehicle**" unless the context otherwise requires, means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along roads whether or not by mechanical power;

"**taxi**" has the same meaning as in Section 23(1) of the Civic Government (Scotland) Act 1982;

"**private hire car**" has the same meaning as in Section 23(1) of the Civic Government (Scotland) Act 1982;

"**disabled person's badge**" has the same meaning as in Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (Scotland) Regulations 2002;

"**disabled person's vehicle**" has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (Scotland) Regulations 1991;

"**emergency service vehicle**" means a vehicle being used by the Police, Fire Brigade or Ambulance Services;

"**pedal cycle**" means a unicycle, bicycle, tricycle or cycle having four or more wheels, not being in any case mechanically propelled unless it is an electrically assisted pedal cycle of such class as is to be treated as not being a motor vehicle for the purposes of the Road Traffic Regulation Act 1984;

"**local authority**" means a council constituted under section 2 of the Local Government etc. (Scotland) Act 1994(a).;

"**Council**" means South Lanarkshire Council;

"public service vehicle" has the same meaning as in the Public Passenger Vehicles Act 1981;

"buses" means (a) before 1st January 1997 (i) public service vehicles used for the provision of local services or scheduled express services; (ii) school buses; or (iii) works buses; and (b) after 31st December 1996 (i) motor vehicles constructed or adapted to carry more than 8 passengers (exclusive of the driver); and (ii) local buses not so constructed or adapted ;

"cyclist" being a person proceeding by means of or with a pedal cycle as defined in the Roads (Scotland) Act 1984 ;

"residents parking permit" ("permit") means a badge or disc issued by the Council, in accordance with the provisions of this Order, to a person who ordinarily resides in a dwelling house in the area within the controlled parking zone ;

"telecommunications apparatus" is as defined in the Telecommunications Act 1984.

"goods" includes postal packets of any description. Delivering and collecting in relation to any goods includes checking the goods for the purpose of their delivery or collection.

3. No Waiting and No Loading at any time

Save as provided in Article 14 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait at any time in any of the lengths of roads specified in Schedule 1 to this Order.

4. No Waiting between certain hours

Save as provided in Articles 14 and 15 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait between the hours of 9:30am and 4:00pm, Monday to Saturday inclusive, in any of the lengths of roads specified in Schedule 2 to this Order.

5. No Loading between certain hours

Save as provided in Article 14 of this Order no person shall, except upon the

direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait between the hours of 7:30am and 9:30pm, and 4:00pm and 6:30pm, Monday to Saturday inclusive, in any of the lengths of roads specified in Schedule 2 to this Order.

6 No Waiting between certain hours

Save as provided in Articles 14 and 15 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait between the hours of 8:00am and 6:30pm, Monday to Saturday inclusive, in any of the lengths of roads specified in Schedule 3 to this Order.

7 No Waiting at Any Time

Save as provided in Articles 14 and 15 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait at any time in any of the lengths of roads specified in Schedule 4 to this Order.

8 Bus Stop Clearway (No stopping 7:00am to 11.00pm)

Save as provided in Article 16 to this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle, other than buses providing a local service to wait between the hours of 7:00am and 11:00pm, all week (i.e. Monday to Sunday inclusive) in any of the length of road specified in Schedule 5 to this Order.

9 No Waiting between certain hours

Save as provided in Articles 14 and 15 of this Order no person other than those displaying a valid residents parking permit (which is issued in accordance with Article 17 of this Order) shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait between the hours of 8:30am and 6:30pm, all week (i.e. Monday to Sunday inclusive), in any of the lengths of roads specified in Schedule 6 to this Order.

10 Bus, Taxi and Cycle lane

No person shall drive or cause or permit to be driven any vehicle, with exception of buses, taxis, private hire cars and pedal cycles, between the hours of 7.30 am and 9.30 am, and 4:00pm and 6:30pm, Monday to Saturday inclusive, in any of the lengths of road specified Schedule 7 to this Order.

11 Waiting Limited to 30 minutes

Save as provided in Article 14 and 15 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait between the hours of 8:30am and 6:30pm, Monday to Saturday inclusive, in any of the lengths of roads specified in Schedule 8 to this Order: -

- (a) for a period longer than thirty minutes; and
- (b) if a period of less than one hour has elapsed since the last period of waiting of the vehicle in any of the said length of road.

12 No Waiting at Any Time except disabled badge holders

Save as provided in Article 15(a) of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle, other than those displaying a valid disabled person's badge, to wait at any time in any of the lengths of roads specified in Schedule 9 to this Order.

13 One Way Operation

No person shall drive or cause or permit to be driven any vehicle on the roads specified in Column 1 of Schedule 10 to this Order, between the point described in Column 2 and that described in Column 3, otherwise than in the direction specified in Column 4 of the said Schedule.

14 Loading Exemptions

Nothing in Articles 3, 4, 5, 6, 7, 8, 9 and 11 of this Order shall :-

- (a) prevent any person from causing or permitting a vehicle to wait in any of the lengths of the roads referred to in those Articles :-
  - (i) for so long as may be necessary to enable a person to board or alight from the vehicle or to load thereon or unload therefrom his personal luggage;
  - (ii) for so long as may be necessary to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the length of the road so referred to, or the laying, erection, alteration or repair in or near to any of the said lengths of the road, of any sewer or of any

main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus as defined in the Telecommunications Act 1984 ;

- (iii) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of statutory powers and duties and in particular, but without prejudice to the generality of the foregoing, to enable the vehicle to be used in connection with police, fire brigade and ambulance purposes ;
- (iv) if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid an accident ;
- (v) if the vehicle is in the service of or employed by the Post Office and is waiting in any of the lengths of the road while postal packets addressed to premises adjacent thereto are being unloaded from the vehicle or having been unloaded therefrom are being delivered or while postal packets are being collected from premises or posting boxes adjacent thereto ;
- (vi) for the purpose of loading or unloading the vehicle while the vehicle is standing at the kerb and is in actual use in connection with the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository ;
- (vii) to enable the vehicle to be used in connection with funeral and bridal operations.

#### 15 Waiting Exemptions

- (a) Nothing in Articles 4, 6, 7, 9, 11 and 12 of this Order shall apply to any disabled person's vehicle which is not causing an obstruction and which displays a valid disabled person's badge issued by a local authority in exercise of its powers under Section 21 of the Chronically Sick and Disabled Persons Act 1970.
- (b) Nothing in Articles 4, 6, 7, 9, 11 of this Order shall prevent any person from causing or permitting a vehicle to wait in the lengths of road referred to in those Articles for so long as may be necessary for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle at premises adjoining that road provided that :-
  - (i) no vehicle engaged in delivering or collecting goods or merchandise or being loaded or unloaded shall wait for a longer period than 30 minutes in the same place and no such vehicle shall wait for a longer period than ten minutes in the same place without goods being loaded onto or unloaded from the vehicle ;

- (ii) notwithstanding anything in paragraph (i) of this Article the driver waiting for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle shall move the same on the instruction of a police constable in uniform whenever such moving may be reasonably necessary for the purpose of preventing an obstruction.
- (c) Nothing in Articles 4, 6, 7, 9, 11 of this Order shall apply to a licensed taxi waiting in a taxi stance during any period for which that stance has been designated by the District Council under the Civic Government (Scotland) Act 1982.

#### 16 Bus Stop Clearway Exemptions

Nothing in Article 8 shall apply :-

- (a) so as to prevent any vehicle waiting in the said lengths of road for so long as may be necessary to enable the vehicle, if it cannot be used for such purpose without so waiting, to be used in connection with any building operation or demolition being carried on adjacent thereto, the removal of any obstruction or potential obstruction to traffic, the maintenance, testing, alteration, repair or removal of any structure, works, or apparatus in, on, under or over the road ;
- (b) to an emergency services vehicle ;
- (c) to a vehicle being used in the service of the local authority or with the permission of the local authority in exercise of statutory powers and duties if it is necessary for the vehicle while being so used to wait in the said lengths of road ;
- (d) to a vehicle waiting in any case where the person in control of the vehicle :-
  - (i) is required by law to stop ;
  - (ii) is obliged to do so in order to avoid an accident ;  
it is not reasonably practicable for him to drive or move the vehicle to a place not within the said lengths of road.

#### 17 Permit Conditions

- (i) Issue and re-issue of permits shall be by an authorised officer of the Council.
- (ii) the number of permits issued to any one person or body will be at the discretion of an authorised officer of the Council.

- (iii) Permits will be renewed annually or any time period designated by the Council on request by the holder provided he/she has conformed to the conditions as laid down by the Council. The expired permit must be surrendered before a new permit will be issued.
- (iv) The permit is the property of and must be returned to the authorised officer of the Council when the holder vacates his/her premises or on request by the Council. The permit is not transferable and must only be used during bona-fide visits to the property issued with the permit of a social or domestic nature.
- (v) The loss or theft of a permit should immediately be reported to the authorised officer of the Council.
- (vi) The permit is only valid in the Zone or Street named on the permit.
- (vii) The residents parking permit shall be displayed on the nearside of the vehicle, behind the glass of the windscreen, in such a position as to ensure that the front side of the permit is clearly visible to any person standing at the front or nearside of the vehicle.
- (viii) Vehicles displaying a permit must park on-street in accordance with the contents of the Highway Code.
- (ix) In the event of any breach of any of the aforementioned conditions the permit relating to the offending vehicle or company or resident may be withdrawn.

18 Amendments

The Orders specified in Schedule 11 to this Order shall have effect subject to the amendments specified in that Schedule.

19 Revocations

The Orders specified in Schedule 12 to this Order are hereby revoked.
